





MAG pilots, sensor operators, trainers, and maintainers operate and support 146+ f_{xed} wing, rotary wing, and unmanned aircraft around the world across a broad range of missions.



The MAG team provides the full spectrum of services from selection of the aircraft and sensors needed to meet mission requirements, the engineering for aircraft modifications and platform integrations, the expertise for aerial ISR aircraft operations, and the post mission analysis to deliver actionable intelligence.

SERVICES

ISR Operations

The MAG team operates, deploys, and maintains manned aircraft and unmanned aircraft systems that provide ISR capabilities for customers all across the globe. We provide our customers the full spectrum of ISR operations: pilots and mission systems operators; maintenance for the aircrafts, sensors and ground control stations; logistics and support; and site and program management.

Multi-intelligence data collection and PED services includes LiDAR, full motion video (FMV), synthetic aperture radar (SAR), hyperspectral imagery (HSI), signals intelligence (SIGINT), and maritime patrol surface search radar.

Examples:

- Deployed multiple manned and unmanned ISR platforms (aircraft and crew) to support several diverse mission profiles in South America, Africa, and the Middle East including support to the United Nations
- Provided turnkey ISR services to NATO using proprietary UAS platform
- Worked with Massachusetts Institute of Technology (MIT Lincoln Laboratories) and Sandia National Laboratories for the integration, fielding, and operation of highly specialized sensing technologies
- Provided Inventory Control Point for entire U.S. Army Fleet of Raven/Puma UAS
- Provided more pilots and sensor operators than any other company in Afghanistan.

ISR Training

The MAG team provides training to conduct manned and unmanned ISR operations worldwide. Training curriculums are customized and tailored to each customer's mission and aviation infrastructure

Examples:

- Deployed 500+ aviation professionals supporting U.S. DOD ISR and training efforts in Afghanistan
- Trained the Royal Malaysia Police to perform Maritime Patrol Operations using their King Air B200 ISR Platform.

ISR Technical Services

MAG engineers provide operations and maintenance for command and control operations centers and ISR network systems. The MAG technical team designs, installs and operates advanced ISR systems, unmanned operation centers, air operations centers', and intelligence support centers. These centers provide real-time dissemination of video, voice, intelligence, command and control, metadata and geospatial information. We also provide software engineering and training solutions that include simulations and assessments and C4ISR instruction.

Examples:

- Built and operated seventeen (17) MQ-1/ MQ-9 Unmanned Operations Centers for US and U.K. squadrons
- Inserted technology into Air Operations Centers (AOCs) for US Central Command (CENTCOM), Northern Command (NORTHCOM), and Southern Command (SOUTHCOM)
- Tested and integrated advanced, airborne ISR technologies for Special Operations Force (SOF) units
- Provided Air Force Distributed Common Ground System (DCGS) Technical Support



The MAG technical services and operational support teams operated 16 operations centers and provided operational support on 5 different customer programs.


The technical services team maintained 100% system availability throughout the entire year. Each center completing an average 2,751 maintenance actions and supported on average over 450 missions.

The operational support team completed a required 72 maintenance inspections, completed 40 training courses and master plans, and tested and evaluated 17 software systems and 9 hardware systems. They developed, reviewed and finalized 1,261 program documents, work-fies and technical manuals.

MAG saving lives one flight at a time




